GROOMING RELEASE FORM

phillydogspot has my permission to do whatever it feels is appropriate for the well-being of my dog. Should **phillydogspot** determine, at its sole discretion, that veterinary care is warranted, I agree to pay all associated fees and costs. If my dog's veterinarian is not readily accessible, **phillydogspot** is authorized to use a veterinarian of its choice. **phillydogspot** will not be responsible for any conditions or problems discovered during grooming. Should veterinary care be necessary as a result of any services rendered by **phillydogspot**, **phillydogspot** must be notified within 48 hours of such care. Reimbursement for such care will be at the sole discretion of **phillydogspot**.

phillydogspot will not be held responsible for clipper burn, minor nicks, or skin irritation resulting from grooming; nor will we be held responsible for stressful effects that grooming may have upon a geriatric pet.

phillydogspot shall not be held liable for any after-grooming effects of de-matting clipping procedures or problems uncovered on a badly matted or otherwise neglected coat including, but not limited to: itchiness, skin redness or self inflicted irritations/abrasions from excessive external rubbing. I understand that time and costs associated with de-matting are unpredictable and subject to the particular condition of my dog; consequently, I agree to pay whatever fees are incurred as a result of de-matting. Whether a dog is "matted," furthermore, is at the sole determination of **phillydogspot**.

I agree to pay all costs for the grooming of the dog including, but not limited to, special handling requirements, de-matting, and fees due for late drop-off, pick-up or missed appointments.

phillydogspot reserves the right to refuse to groom any dog for the health and safety of the groomer and the dog. A soft muzzle may be used, or services discontinued or refused if **phillydogspot** determines that a dog presents an unsafe condition. Such conditions include, but are not limited to: behavior issues, health problems, fleas or parasites.

I agree to inform **phillydogspot** prior to grooming if the dog has ever bitten any human or another dog or has any aggressive tendencies whatsoever. I understand and agree that I will be held solely liable for any harm, injury, or property damage caused by my dog.

I understand that missed appointments will incur a fee of 50 % of the estimated grooming charge.

I agree to be ON TIME or up to 15 min. early for your appt. If I am over 15-20 min. late, I understand that I may be required to re-book (missed appointment fees may apply).

I agree to pick my dog up at the arranged time. I further agree to pay the late pick-up fee of \$10 for every 15 minutes.

Should I have to cancel my dog's appointment, I agree to notify **phillydogspot** no sooner than 24-hours prior to the scheduled appointment. If **phillydogspot** does such notice, I agree to pay a re-booking fee of 50% of the estimated grooming charge (emergencies will be considered on an individual basis).

I agree to make sure my dog has relieved itself prior to drop-off.

I affirm that I am the rightful legal owner of the dog for which services are rendered.

I have read, understand, and agree to the policies of **phillydogspot** as set forth in this form.
